# AN ACT TO ENSURE ACCOMMODATIONS ARE MET FOR DEAF AND HARD OF HEARING STUDENTS AT THE UNIVERSITY OF ALABAMA BY PROVIDING CLOSED CAPTIONING FOR ALL PUBLIC MULTIMEDIA PRESENTATIONS

Be it enacted by the First Year Council of the Student Government Association assembled.

#### Section 1. Findings:

1. According to section 36.202 of The Americans With Disabilities Act under Title III regulations state "(b) *Participation in unequal benefit*. A public accommodation shall not afford an individual or class of individuals, on the basis of a disability or disabilities of such individual or class, directly, or through contractual, licensing, or other arrangements, with the opportunity to participate in or benefit from a good, service, facility, privilege, advantage, or accommodation that is not equal to that afforded to other individuals." and, under Section 36.303 of Title III of the Americans with Disabilities Act also states "(c) Effective communication. A public

- accommodation shall furnish appropriate auxiliary aids and services where necessary to ensure effective communication with individuals with disabilities."
- 2. Deaf and Hard of Hearing students at the University of Alabama have raised concerns considering the lack of accommodation for deaf and hard of hearing students in media presentations and have expressed a desire for closed captioning in media presentations
- 3. Without proper accommodations like closed captioning in media presentations given by on campus organizations, students that are hard of hearing or deaf cannot participate
- 4. The purpose of the University of Alabama is to prepare students for success postgraduation and promote civil engagement and foster inclusion for all students no matter disability
- 5. Promoting the use of closed captioning on all multimedia presentations in all student organizations on campus should be encouraged to increase accessibility on campus
- 6. The Office of Information Technology can now provide a *Rev* captioning account through the SGA advisor for the SGA to facilitate closed captioned content to campus organizations ensuring that all requirements are met for accessibility

#### Section 2. Legislation:

- 1. Therefore, be it resolved, in the interest of inclusion of all students including deaf and hard of hearing students, the SGA Senate directs the Financial Affairs Committee of the SGA to require all registered student organizations that receive Student Government Association and Financial Affairs Committee Funding be required to include closed captioning on all public facing media presentations through Rev to engage and include the entire student body at the University of Alabama.
- 2. *Therefore, be it further resolved,* the SGA senate strongly encourages all registered student organizations utilizing public facing multimedia presentations to utilize the SGA and the University of Alabama's free closed captioning resources and software

# AN ACT ESTABLISHING STUDENTS TO KNOW THE IDENTITIES & FUNCTIONS OF THEIR COUNCILORS

Be it enacted by the First Year Council of the Student Government Association assembled.

#### Section 1. Findings:

- 1. First Year Councilors are freshmen's "go-to representative for SGA in their pocket of campus" according to the SGA website. Additionally, it is stated that "You'll listen to the concerns of your peers and work with your fellow councilors and other members of SGA to understand and address common challenges through the creation of policy and programs."
- 2. Many first-year students do not know which students act as a First Year Councilor or who is a representative of their housing community. A study conducted by Rachel Narbo confirms this finding.
- 3. Additionally, most freshman on-campus students are not aware of what the First Year Council is meant to accomplish.
- 4. Students have concerns and ideas to improve the first-year experience at the University of Alabama but do not know where to voice their concerns.

#### Section 2. Legislation:

- 1. **THEREFORE**, be it resolved, the University of Alabama First Year Council will make available both the contacts and duties of first year councilors through a variety of channels such as informational posters within residential halls and social media posts as deemed appropriate and necessary.
- 2. **Be it further resolved,** this act will be enacted as soon as it is passed and with the possibility of continuing for later FYC groups.

# A BILL TO AMEND THE SENATE RULES AND REGULATIONS TO ALLOW ONLINE AUDIO/VIDEO PLATFORM PARTICIPATION IN SENATE MEETINGS

Be it enacted by the Senate of the Student Government Association assembled.

#### Section 1. Findings:

- A. On Campus Accessibility The Forum Room, used for a majority of Senate Meetings, has a maximum occupancy of 65, preventing students from being able to fully participate to the extent students are allotted. Further, alternative room options are not feasible with the current SGA budget.
- B. Distance Learning As graduate students and distance learners often have less access to the physical campus, alternate modes of engagement are simultaneously beneficial and necessary. Audio/Video platform participation allows students who cannot physically attend the ability to actively participate. This (a) reduces the number of unnecessary proxies,(b) boosts student representation, and (c) allows for a larger section of the student population a means of participation. Additionally, distance students have readily had the desire and willingness to participate more actively in student life/extracurricular activities.
- C. Feasibility The Forum Room already has the capacity to do this, and Senate (currently, though not mandated to) allows Audio/Video platform participation for Senators. That same accessibility can be extended to the campus through a public access link.

Section 2. Legislation: changes in red

#### **Chapter 500 Senate Meetings**

Chapter 500.1 Senate will meet every Thursday at 18:30 at a designated location.

Chapter 500.1.1 A link to participate in Senate Meetings over Audio/Video platforms shall be distributed via the SGA website homepage at least an hour before the designated meeting.

Chapter 500.2 Senate will operate on a biweekly schedule, alternating between Formal Meetings and Committee Meetings.

Chapter 500.2.1 Formal Meetings

Chapter 500.2.1.1 Formal Meetings will occur once every two (2) weeks. Chapter 500.2.1.2 Old Business of the Senate may only be scheduled during Formal Meetings of the Senate.

Chapter 500.2.2 Committee Meetings

Chapter 500.2.2.1 Committee Meetings will occur once every two (2) weeks, alternating with Formal Meetings.

Chapter 500.3 In the event that the location or time is an issue such that a meeting cannot be held, or if the University of Alabama has suspended operations some time on the day of the meeting, the Speaker of the Senate shall be vested with the authority to cancel the meeting and shall notify all Senate members should he or she decide to take such action.

Chapter 500.4 Formal Senate Dress Code

Chapter 500.4.1 Senators must wear business attire for all formal Senate meetings and all special sessions of the Senate.

Chapter 500.4.2 The requirement of business attire shall not be construed such that it applies to proxies.

Chapter 500.5 Prior to the commencement of legislative business, the Speaker of the Senate shall open the floor to members of the public for the purposes of voicing the concerns and the opinions of the student body and the presentation of petitions.

Chapter 500.5.1 Members of the public will be permitted at least but not exceeding three minutes per person for a total of thirty minutes.
