**A BILL TO APPROVE THE SENATE RULES AND REGULATIONS FOR THE 27<sup>TH</sup>  
SENATE**

*Be it enacted by the Senate of the Student Government Association assembled.*

**Section 1. Findings:**

A. Keeping in the upkeep of procedural norms within the Senate serves as a way for the chamber to elevate debate as a new class of senators' form.

**Section 2. Legislation:**

**Chapter 200 The Parliamentarian of the Senate**

**Chapter 200.2.4** The Parliamentarian will serve as a non-voting member of the Rules Committee

**Chapter 202 The Director of Initiatives**

**Chapter 202.1** The Director of Initiatives will be responsible for the effective execution of Senate initiatives and programming events to promote Senate visibility and accessibility.

### **Chapter 400.2 Jurisdiction over Legislation**

#### **Chapter 400.2.3 Endorsements**

**Chapter 400.2.3.1** Any Source registered organization and Student Government Association member shall be permitted to endorse any legislation presented to the Student Senate.

## **Chapter 501 Special Rules of the Senate**

**Chapter 501.4** During the first reading of legislation, the author will present it before the body of the Senate where it will be assigned to a committee at the discretion of the Speaker.
