Student Elections Board Ruling

ELECTION: Spring 2023 SGA General Election

HEARING DATE: February 27, 2023

COMPLAINANT: Robbie Khalil

ALLEGED: Xzarria Peterson, VP for Diversity, Equity, & Inclusion Candidate

ELECTION CODE VIOLATION(S): XIX.D.1. Election Fraud & XIX.D.2. Campaign Ethics

ELECTIONS BOARD DECISION:

By a vote of 7-0, the Elections Board found the Peterson Campaign in violation of XIX.D.1. Election Fraud which is defined “as any willful act, deed, or conspiracy that violates the integrity of the electoral process before, during or after actual voting occurs.” Elections fraud includes but is not limited to “attempting, with or without success, to coerce or procure votes by the use of threats or intimidation” and XIX.D.2. Campaign Ethics Violations. The Elections Manual specifically states that “candidates are expected to conduct themselves in an ethically appropriate manner in accordance with Student Government Association documents and the Code of Student Conduct” and details prohibited actions, of which include “coercing or using valuable incentives to induce an individual to vote for a particular candidate or issue.” After review of the violation, the Board finds Peterson’s actions in the “Progress with Peterson” GroupMe to be both fraudulent and unethical. The messages sent by candidate Peterson encourage manipulation and actions contradictory to the Capstone Creed and Student Elections Manual.

In a hearing with the Board, Peterson stated that the “Progress with Peterson” GroupMe was private, and that all persons in the GroupMe were close friends and as such, understood the ‘intention and joking nature’ of her remarks. It was determined that a link to join the Progress with Peterson GroupMe was posted publicly on Peterson’s Instagram. It is the opinion of the Board that as an individual in the GroupMe clearly took issue with the messages, it is incorrect and dismissive to claim that all persons understood the ‘intention and joking nature.’ Further, Peterson shared with the Board that after receiving the elections violation, she and her campaign team removed individuals from the GroupMe with whom they did not share a personal relationship. Additionally, Peterson stated that in the hours following the contentious messages being sent, she sent a clarification as well as a link to the Elections Manual. It is the opinion of the Elections Board that simply sending a clarification hours after the original message

does not exonerate nor justify her previous statements. The Elections Board expects all candidates to conduct themselves in a professional and ethical manner, and furthermore expects all candidates to behave in a manner that supports diversity, equity, and inclusion.

PENALTY:

The Peterson Campaign is awarded 18 points for two major campaign violations. Given that an accumulation of twelve points or a conviction of a major violation allows the Board to consider disqualification, a vote was called, and the Board decided unanimously to disqualify Xzarria Peterson from the Spring General Election.

Further, she states "and be ridiculously annoying about it" "like im talking reposting in the class of "whatever" snap stories annoying". Jackson Olmstead goes on to say, "YESSSS I'll be like post this or ur ugly and dirty and big" then to say "and then they'll do it because they want to be skinny and petite and tiny and cute." This is a gross, and detrimental, violation of the elections manual as it is clear coercion and voter fraud. Forcing another member or "manipulating" them to vote is not only against the Capstone Creed, but the elections board manual. This was stated in an outreach GroupMe made by the Peterson team, and should be addressed ASAP to keep the integrity of our elections process.





Good morning,

I am more than happy to meet with you all today or at a later date to discuss this further. At this time, it is the campaign's position that the allegation of the violation of Article XIII of the Elections Manual lacks merit. While I cannot deny sending the private GroupMe messages listed in the complaint, the campaign did realize the possibility of misinterpretation of the previous messages. Therefore, I did follow up with this statement two separate times the same day, once at 5:04 pm, with a link to the Elections Manual asking everyone to review it, and again at 9:55 pm, explicitly stating ground rules to begin the campaign period, that all campaign volunteers should follow. All campaign volunteers had previously worked with me last year and are well-versed with the Elections Manual and have not violated the integrity of the electoral process before voting, and we intend to continue to uphold the same standard for the remainder of the campaign period and also after voting.

Additionally, it is the firm position of the campaign that at no point, did we commit any willful act, deed, or conspire to procure votes. The messages that were submitted as part of the complaint were referring to campaign graphics on social media and were not persuading a student to vote in any particular way, nor interfering or tampering with their right to vote. We also vehemently deny that the campaign encouraged any students to vote in place of another student, to coerce or procure votes by payment, delivery, or promise money or another article of value, or by use of threats and intimidation, nor did the campaign make disparaging assertions with the intent to defame other candidates or campaigns in the messages submitted as part of the complaint. The language used in the messages, specifically the lack of proper usage of grammar and excessive use of adjectives implies that the messages sent would be understood by any reasonable person as not an official position of the campaign, nor a sincere remark.

I would like to continue to reiterate that the messages submitted with the complaint were in reference to asking others to share social media graphics and were not asking any students to vote for a particular person

In conclusion, the campaign understands the magnitude of the allegations being brought against us but firmly believes that these allegations lack the merit to be considered a violation of Article XIII of the SGA Elections Manual. We look forward to the opportunity to further explain the campaign's position relating to these allegations to the Elections Board and we thank you for reaching out to us regarding this allegation.

This email is to notify you that an Elections Violation Complaint was received against your campaign. Filed by Robbie Kahlil, the submissions alleges a violation of [Election Code XIII](#).
ELECTION FRAUD

Election fraud shall be defined as any willful act, deed, or conspiracy that violates the integrity of the electoral process before, during or after actual voting occurs. Elections fraud shall include, but not be limited to, the following acts: 1. Attempting, with or without success, to vote in place of another. 2. Attempting, with or without success, to coerce or procure votes by the payment, delivery, or promise of money or other article of value. 3. Attempting, with or without success, to coerce or procure votes by the use of threats or intimidation. 4. Retaliation for reporting election violations. 5. Making disparaging assertions with the intent to defame other candidates or campaigns. 6. Tampering or interfering with an election or a student's right to vote in the same, including, but not limited to, requiring someone to provide evidence of voting in an election.

More specifically, the complaint states that on 02/20/2023 at around 4:40 pm, "in the GroupMe titled 'Prosper with Peterson' Xzarria Peterson is shown saying 'like if you know athletes, other folks who you can easily manipulate into reposting: DO IT.' Further, she states 'and be ridiculously annoying about it' 'like im talking reposting in the class of 'whatever' snap stories annoying'. Jackson Olmstead goes on to say, 'YESSSS I'll be like post this or ur ugly and dirty and big' then to say 'and then they'll do it because they want to be skinny and petite and tiny and cute'."

This email, however, is NOT to notify you that you have received violation points by the Elections Board, but a request for your response to these allegations, including if you were invited by the organization to speak at the meeting. **According to the Elections Manual, you have twelve (12) hours to reply to the alleged violations for review by the Elections Board.**
